  - a. Tara volunteered to take the role as the new community leader.

## Agenda items:

- 1. Website
  - a. New TSRG website will launch in January 2025
  - b. Minutes, agendas, and roster will be available on the website after launch
  - c. Before the new website is completed, individuals can received copies of meeting materials by request
- 2. Long term goals
  - a. Identify what organizations play what roles in this project
    - i. The group discussed adding contact with Southeast Business Retention Expansion Attraction (SEBREA) ran by Danelle Berg and Southeast Colorado Enterprise Development (SECED) ran by Stephanie Gonzales. Referring them both to Tara after initial contact has been made.
  - b. Identify what services or programing is needed
    - i. The goal for AmeriCorps hires is to create a program to counsel people in recovery who are returning to the workforce. Develop a communication strategy
    - ii. The group brainstormed communication strategies.
    - iii. In addition, participants suggested contacting Tri County Family Care Center. The group discussed recovery friendly businesses and housing.
  - c. Identify recovery friendly employers
    - i. To begin the conversation, the definition of recovery friendly and legislation about funding that can affect employers was in question.
    - ii. Kristen Capenter offered to connect the group to her contact from CU Anschutz who could give a quick presentation on recovery freindly workplace initiatives in Colorado.
    - iii. Steps to take to identify recovery friendly employers: Define "recovery friendly," create a list of criteria that recovery friendly workplaces cover, create a list of workplaces that meet the criteria.
    - iv. Several participants talked about the employer perspectives of this goal including the need for explicate ideas of what accommodations employers need to be aware of.
